Grounds— From Rd. 3 North in Chino Valley, go North on US 89 approximately 9.1 miles to Verde Ranch Road. (approximately 3/10 miles past mile marker #338) Turn right onto Verde Ranch Road. Follow signs to trial grounds. Approximately 6 miles.

From Ashfork on I-40 go South on Highway 89 approximately 24 miles to Verde Ranch Road (about 7/10 mile past mile marker #339) turn left and follow signs to grounds.

Camping—Overnight camping will be allowed during the dates of the trial ONLY. All parking will be parallel along developed forest roads. All participants shall insure the tires, wheel wells, and undercarriage of all vehicles on site are free of any weeds or other vegetation prior to entering the area of the event. Participants shall use only state certified noxious weed free hay, grain, straw, pelletized feed prior to and during the event for stock that will be on-site. Participants must fill all holes and scatter all horse manure before leaving. Open fires will not be permitted" Please carry off your trash and fill in any holes. Please spread horse manure and any leftover hay.

Certified Weed Free Hay

We have made arrangements with Olsen's Grain in Chino Valley to supply the certified weed free hay that is required. It will be available on the grounds (by reservation) and also at their store, 344 S. Highway 89 in Chino Valley. Alfalfa Only.
