Camping—Overnight camping will be allowed during the dates of the trial ONLY. Camp parking will be on private property adjacent to the Field Trial Area. Please follow instructions upon arrival. **Participants shall use only state certified noxious weed free hay, grain, straw, pelletized feed prior to and during the event for stock that will be on-site.** Participants must fill all holes and scatter all horse manure before leaving. Open fires will not be permitted, Please carry off your trash.

This field trial will be run under the "Flexible Format." Entries are limited to the number of dogs that can run in all available daylight hours and entries will close when that limit is reached, even if that occurs prior to the closing date. The Field Trial Committee reserves the right to rearrange the running order and add/rearrange judges should conditions warrant.

Dogs which first qualify at this trial will NOT be allowed to enter the Limited Gun Dog stakes.

COURSES AND BIRDS:

All stakes will be a single course without bird field. Chukar and/or quail will be released in all stakes except Open Puppy. A blank cartridge will be fired in the puppy stake.

PRIZES:

Standard AKC Rosettes to all placed dogs. Trophies to all first place dogs in Open All Age, Open Limited Gun Dog, Open Gun Dog, Amateur Gun Dog and Amateur Limited Gun Dog. Trophies to first through fourth place in both Open Puppy and Open Derby
